UIA & UPF discuss MTP Enforcement

We hosted a team from the Kampala Metropolitan Police at Protea Hotel on 26th July, 2023. At the Breakfast Meeting, the UIA team led by CEO – Jonan Kisakye and the Uganda Police Force (UPF) led by the then Kampala Metropolitan Traffic Police Commander, Senior Superintendent of Police (SSP), Rogers Nsereko Kavuma agreed to jointly work towards the smooth implementation of Motor Third Party Insurance across the country.

The engagement was highly interactive and generated feedback from the officers on how best Motor Third Party Insurance enforcement can be implemented.

Subsequently, we sponsored a Farewell Dinner for the now out-gone Kampala Metropolitan Traffic Police Commander, Senior Superintendent of Police (SSP) Rogers Nsereko Kavuma. The colorful event took place on 4th August, 2023 at Fairway Hotel.

The survey that targeted employers, employees and other key stakeholders across 17 districts kicked off on 24^{th} August, 2023.


The Association is trying to undertake research & utilize it for product development, market development and to inform the public better.

User Acceptance Test on the integration between IRA & URA on Marine Cargo Insurance Policy Implementation.

On 5th September, 2023, our team took part in the user acceptance test for Marine Cargo Insurance Policy implementation that took place at Uganda Revenue Authority (URA) Headquarters in Nakawa.

The discussion revolved around the implementation of the directive by the Ministry of Finance, Planning & Economic Development to have all incoming cargo locally insured under Local Marine Cargo Insurance Policy that commenced this month.

Subsequently, an engagement on Management of Claims under Marine Cargo Insurance took place at our offices on 6th September to prepare industry players for its roll out. Claims Managers from our Non-Life members discussed how to handle Claims under the Marine Cargo Co-Insurance. They received valuable insight on the proposed Claims Management System and they shared their feedback on the same.

In the same vein, we held a User Acceptance Test for insurers at Fairway Hotel on 19th September, 2023 in preparation for the implementation of the Local Marine Cargo Insurance directive.
